

Personal Data Protection Clause

applicable to Bidders/Contractors being natural persons and natural persons engaged in business activity, incl. partners in a civil partnership.

1. Inowrocławskie Kopalnie Soli "Solino" S.A. with its registered seat in Inowrocław, Św. Duchy 26a, 88-100 Inowrocław, is your personal data Controller. Data Controller's contact telephone number(s): +48 (24) 256-76-26; +48 (24) 256-94-60

3. Your personal data is processed for the following reasons:
 - a) to establish cooperation, to conclude and perform a Contract in which you are a party,
 - b) to fulfil legal obligations of Inowrocławskie Kopalnie Soli "Solino" S.A. under applicable law, including in particular obligations under tax and accounting law, obligations of an obliged institution, obligations under anti-money laundering and terrorist financing law, obligations related to the law on counteracting fraud and abuse in connection with anti-corruption legislation and other regulations arising from the specific nature of the relevant contract.
 - c) to verify the correctness and validity of your data, the credibility of the contractors of IKS "Solino" S.A., or persons connected with the contractors, including checking their business background, legal and financial standing, in order to protect the economic and legal interests of IKS "Solino" S.A.
 - d) to ensure the security of IKS "Solino" S.A. preventing fraud and corruption, as well as to detect and prevent fraud and conflict in business processes, and to maintain high ethical standards,
 - e) to establish and maintain business relations, including maintenance of appropriate communications in writing or by phone,
 - f) to carry out internal business reviews related to contractor services, terms and conditions of on-going business cooperation or the possibility of its development,
 - g) to establish, assert and handle claims,
4. The legal basis for the processing of your personal data by IKS "Solino" S.A. for the purposes specified in Section 3 above is:
 - a) concluding and performing the Contract, and undertaking actions if requested by data subject, before concluding the Contract (according to Art. 6, Sect. 1 b) of the GDPR) for the purposes listed in Sect. 3 a);
 - b) fulfilling legal obligations of Inowrocławskie Kopalnie Soli "Solino" S.A. (according to Art. 6, Sect. 1 c) of the GDPR) as regards compliance with the law, regulations and sector-specific guidelines;
 - c) the legitimate interest of Inowrocławskie Kopalnie Soli "Solino" S.A. (as per Art. 6. Sect. 1 f) of the GDPR) for the purposes listed in Sect. 3 c) to h).
5. Your personal data has been disclosed directly by yourself or obtained from publicly available registers (e.g. KRS, CEIDG etc.), websites maintained by you for the purpose of your business activities, and from entities providing IKS "Solino" S.A. with digital data compilation and provision services for updating/supplementing or verification of information.
6. Your personal data may be disclosed by Inowrocławskie Kopalnie Soli "Solino" S.A. to entities working with IKS "Solino" (customers) in the performance of the Contract, to ORLEN Capital Group companies, if necessary for the processing purposes referred to in Section 3, and to entities providing IT services, invoicing services, accounting services, mailing, archiving, consultancy, legal, collection, and security services.
7. The disclosure of your personal data is voluntary, however it is indispensable to establish cooperation/business relations, to conclude and perform the Contract and to fulfil the purposes specified in Section 3 above.
8. Your personal data processed under the Contract is processed for the duration of the Contract. At the end of this period, IKS "Solino" S.A. will retain your personal data - if required to do so by law - for the period prescribed in the relevant law, or to pursue the legitimate interest, including until the expiry of any mutual claims under the Contract. If the data is processed based on a legitimate interest, the data will be processed for such time as to enable IKS "Solino" S.A. to fulfill the interest, or until an objection is effectively raised to the processing of the data.
9. You have the following rights related to the processing of your personal data:
 - a) to request access to your personal data,
 - b) to demand rectification of the data,
 - c) to demand erasure or restriction of processing of the data,
 - d) to transmit the data,
 - e) to object to the processing of your data - in the event that IKS "Solino" S.A. processes your personal data under its legitimate interest; an objection can be made in specific circumstances.
