

Personal Data Protection Clause

applicable to members of governing bodies, authorized representatives or agents representing the Bidder/ Contractor/Supplier*, as well as to employees who are contact persons, and persons working with the Bidder/Contractor/Supplier* on the execution and performance of contracts for Inowrocławskie Kopalnie Soli "Solino" S.A.

1. Inowrocławskie Kopalnie Soli „Solino" with its registered address in Inowrocław at Św. Ducha 26a, 88-100 Inowrocław, is your personal data Controller. Data Controller's contact telephone number(s): Tel.: +48 (24) 256-76-26; +48 (24) 256-94-60.

3. Your personal data submitted to Inowrocławskie Kopalnie Soli "Solino" S.A. by an entity engaged or intending to engage in business relations with Inowrocławskie Kopalnie Soli "Solino" S.A. constitute - depending on the nature of the relations - data necessary for representation of a legal entity, contact data, or information included in documents in your possession that confirm certain competence, qualification or experience.
4. Your personal data may be processed by IKS "Solino" S.A., depending on the nature of the relations, for such purposes as:
 - a) compliance with obligations resulting from a contract with IKS "Solino" S.A. the entity named in Section 3 is/will be a party to, and in particular to verify declarations made by the entity named in Section 3, including to confirm the authorization to represent, or qualifications of individuals appointed to perform the contract, to enable contact during the performance of the contract, to communicate, to grant powers of attorney or representation of IKS "Solino" S.A., to supervise the correct performance of the contract, to settle the contract, to ensure confidentiality and occupational health and safety,
 - b) handling, asserting and defending a claim, including claims between IKS "Solino" S.A. and yourself, or between IKS "Solino" S.A. and the entity named in Section 3,
 - c) fulfilling legal obligations of Inowrocławskie Kopalnie Soli "Solino" S.A., especially those related to the act on counteracting money laundering and terrorist financing, the construction law, the Regulation (EU) of the European Parliament and of the Council on market abuse, or any other regulations resulting from the specific nature of the relevant contract.
5. The legal basis for the processing of your personal data by IKS "Solino" S.A., depending on the business relation, for the purposes specified in Section 4 above is:
 - a) The legitimate interest of Inowrocławskie Kopalnie Soli "Solino" S.A. (as per Art. 6, Sect. 1f) of the GDPR) which consists in enabling correct and efficient performance of the Contract between IKS "Solino" S.A. and the entity named in Section 3,
 - b) fulfilling legal obligations (as per Art. 6, Sect. 1 c) of the GDPR) of IKS "Solino" S.A..
6. Your personal data may be disclosed by Inowrocławskie Kopalnie Soli "Solino" S.A. to entities working with IKS "Solino" S.A. (customers), and in particular to entities providing IT services, mail services, protection and security services, occupational health and safety services, consultancy services, legal services and archiving.
7. Your personal data is processed for as long as necessary for the legitimate interest of IKS "Solino" S.A. and to perform any legal obligations. The period of data processing may be extended only if and to the extent that is required by law.
8. You have the following rights related to the processing of your personal data:
 - a) to request access to your personal data,
 - b) to demand rectification of the data,
 - c) to demand erasure or restriction of processing of the data,
 - d) to object to the processing of your data in the event that IKS "Solino" S.A. processes your personal data under its legitimate interest; an objection can be made in specific circumstances.Your demand or request concerning the above rights can be made by e-mail sent to the following address: daneosobowe@solino.pl or to the address of IKS "Solino" S.A. provided in Section 1 above, attention of *"Inspektor Ochrony Danych"* (*Data Protection Supervisor*).
9. You have the right to complain to the President of the Personal Data Protection Office.
